NARRATIVE

On 5/18/2024 at approximately 0330 hours, several individuals called 911 to report a shooting in the proximity of the Hookah Lounge Marrakech located at 3442 17th Street, Sarasota. The callers reported that several gunshots were fired in the parking lot area of the Hookah Lounge, and there were several victims struck by gunfire.

Upon deputies' arrival, they discovered multiple victims with gunshot wounds located in the parking lot. One of the victims, identified as Tommie L Battie IV, sustained a single gunshot wound to his chest and was pronounced deceased at the scene. A second victim, identified as Tommie's [redacted] Brian R Battie, was critically injured after sustaining a gunshot to his head. He was transported to Sarasota Memorial Hospital for further treatment.

Three additional victims, Lee A Claridy [redacted], Tosha L Johnson [redacted] and Broderick B. McDaniel [redacted] were also treated for gunshot wounds at Sarasota and Manatee Memorial Hospital.

Video footage obtained from the surrounded businesses showed that the shooting took place at approximately 0329 hours. A black male suspect, later identified as the defendant, Darryl Bernard Brookins Jr, wearing a gray hooded sweatshirt and gray pants, is seen leaning against the window of the business "Choice Vacuum", located at 3444 17th Street. Tommie and Brian Battie are seen walking towards Brookins at which point Brookins immediately drew a firearm and began shooting at both Tommie and Brian Battie. The Battie [redacted] both returned gunfire, at gunfire, at which point Brian is seen falling to the ground. Next, Tommie fell to the ground and later died of his injuries.

Brookins fled on foot, traveling east on 17th Street immediately following the shooting. In the hours following the shooting, detectives received multiple Crimestoppers tips reporting that Darryl Brookins Jr. shot Brian and Tommie Battie.


Brookins left his vehicle, a 1998 Green Chevrolet SUV with FL license Plate RINB61, at the crime scene when he fled on foot. His car was located just west of the shooting location. After comparing photographs of Brookins driver's license photo and open-source social media accounts with the surveillance footage of the incident, detectives were able to positively identify Brookins as the shooter who murdered Tommie and critically injured Brian Battie.

After review of Darryl Brookins' criminal history, Detectives learned that Brookins has four (4) prior felony convictions, all of which were adjudicated guilty.

Based on the aforementioned facts and circumstances, probable cause exists to charge Darryl Bernard Brookins Jr. in violation of F.S.S 782.04(2) Murder, and F.S.S 790.23(1a) Felon in Possession of a firearm.


